Income, from small to large: \$5.40 interest on the Money Market; \$843.00 Chapter Rebate (2Q2018); and the \$10000.00 REI grant (via Anne).

Expenses: the two biggies were, of course, Rockland's, \$3440.00 to Grillo for clay for the pump track, and \$11000.00 to Josh Gee for time and equipment to get it done. I also put \$6.70 postage reimbursement to Rockland as it was Priority Mail for Josh's check. To the Trail Care Fund, I put \$111.91 in stuff for River Highlands, and the \$200.00 deposit check to the VFW for hall rental for November's trail school. To the General: \$110.01 meeting refreshments, \$22.22 for some office supplies, and our annual \$300 (\$250 dues, \$50 donation) to CFPA.

Several and many transfers between operating checking and Money Market to keep just enough in checking - these appear on the bank recs.

I have a receipt from Jon Petersen for some additional Rockland stuff, which will appear in my next report. I'll not steal his or Jason's thunder by discussing the progress at Rockland in my report.

Four outstanding checks: Josh's, the deposit for the VFW hall, Grillo's, and the postage reimbursement. (Postage and Grillo have since come in.)

Upcoming: Fall Fiesta: I'm guessing we're having pizza again. Swag?? We still have some socks, and those Pedro's openers.

Trail School: presently two are enrolled and paid. We're charging \$35, which is to include morning Dunk's, lunch between classroom and practicum (I'm thinking trays from Zerio's, depending on final #s), and materials. We can no longer get a bulk discount on copies of Trail Solutions, so they're on their own to get a copy (e.g. from Amazon) if they want one. I'm thinking we should consider some sort of scholarship for chapter members, to take the form of a rebate check on course completion. We can discuss at the meeting.

Ben Meadows (where we got the pin flags with the logo) was just eaten by Forestry Suppliers. I contacted FS about the possibility of getting more (and what it would cost) - I have a promise to get back to me, but hasn't occurred as of yet.

Paula is looking for a few bucks from us to support having Abby from KT down for a conference. It's on mission, so I have no objection.

Also from Paula (actually her chapter): they're having a trail day, sponsored by REI (they're paying for pizza), the day after our Fall Fiesta, at Rockhouse Hill Sanctuary in Oxford. I've been cross-promoting it in our FF communications. If nothing else, a good free-pizza-and-schmooze-with-REI opportunity. (Ethical disclosure: it's also my home trail system.)

SJ35 is apparently on the ballot as Question #2. More on the referendum and ProteCT as I receive it from Eric Hammerling.

Reminder that, technically, my last day as treasurer is Fall Fiesta. So, for now,

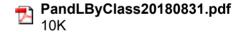
