Once again, since I know everyone is more than capable of reading a P&L, I won't go item by item. There were several notable happenings, though, that caused (or will cause) the bulk of the impact on the treasury for this report and the one to follow:

Rockland: In addition to some parts and supplies for the water system, we needed to get Josh back to take care of some drainage issues at the pump track. We also bought a bunch of tarps to cover the pump track. when it's closed for the season. Jon and Jason can provide details.

Pin Flags: We took up the mantle of managing a group buy of flags with the NEMBA logo for the entire organization. After our initial purchase of 1000 to see how they were. I polled the other chapters via the BoD list for interest... and there was interest. We needed commitment for ten thousand flags to pull the trigger, as at that level it would be cost effective. We got requests for 11.800. After consulting with NEMBA leadership, I ordered an additional 14,000, at a cost of \$1117.61, or 7.98 cents per flag. To make the math easier, we told the chapters to reimburse us \$8/bundle of 100. At present we've delivered all requested except 1,300 (3 chapters that weren't at the Danvers BoD meeting). We also filled a request for an additional 2 bundles not part of the original request. Of those distributed, we've been reimbursed \$480, with another \$376 on the way (and more when the other three chapters get theirs). All told, there's still a box of 2,000 not yet spoken for, but I'm guessing they'll go at the spring BoD meeting. A full report will be provided at the conclusion of the exercise.

Trail School: As of this writing, it's done. 15 students, 2 instructors. We had to punt the practicum due to high winds, but the classroom session got raves. Full report when the final accounting is in. Not cheap, but training is something we need to do.

Fall Fiesta: I couldn't be there, so can't speak of it, and just got a bunch of receipts from Glenn, which will be in my next report.

CT Trails Symposium: At the last meeting, we approved a request to fund \$100 to bring Abby Long, ED at Kingdom Trails, down to speak at it. Originally I thought we'd be kicking those funds to the HV chapter and they'd be handling it, but per Paula I sent it directly to Abby. This is reflected in the odd GJ entries on the P&L that QuickBooks adds when you void a check. In any instance, we footed the night-before dinner of NEMBAfolk, along with Abby and Laurie Giannatti, and Glenn and I attended the conference the next day to represent us.

A couple days after the board meeting in Danvers, I got hit with a sinus infection. On Thursday it started heading toward my lungs, so found myself on antibiotics. Teaching trail school was largely due to downing the better part of a Box O Joe myself. Still recovering.
