Anyway, we have approx. 170 members, and at our commitment of \$10/member/year, that's \$1700 for trail earmarks. Added to the remainder from last year (and a bit of rounding), \$3750 is not unreasonable for this season. We can discuss earmarks at the meeting.

Financial report to Anne is due soon. I'm going through each transaction to be sure I've coded them properly - we're being audited, don't forget, and the auditor is very picky especially about use of restricted funds. If I have questions about something you've submitted I'll ask. If I have to correct anything, it will be noted in my next report.

The Great Give 2019 is in May. Honestly I don't know if we're in or not: I've been asking for summaries of last year's work, and projected work for this year, and haven't gotten any, so our giveGreater profile hasn't been updated. I'll follow up with the Foundation. I can't do anything for it this year beyond the de minimis, as those (personal and work) time commitments I've been talking about for the past year have arrived.

Speaking of: items to discuss at the meeting will include possible scholarships for the April summit, as well as representation on the NEMBA corporate board. It's probably time for someone else to transition in as rep.
