The Great Give 2019: we did reasonably well, considering we really didn't give it the effort warranted. Part of that (lack of effort) on my end was due to the uncomfortable position I'm in, now that many of my donors from past years are in Housatonic Valley's bailiwick instead of ours. Moving forward, somebody really needs to be put in charge of this, as well as maintaining our relationship with the Foundation generally. (I know, I know, I covered this in my last report. It bears repeating.) Did the "soft-ack" thank yous go out to our donors? If not, that needs to happen soonest.

NEMBAfest 2019 is in the books. The weather wasn't perfect, but nor was it terrible. Rain earlier in the week made both the venue and camping fields a muddy mess, though. That said, we dodged a pretty big weather bullet Saturday night, with severe storms (with hail) passing just a couple towns away. This year, I came up the Tuesday before instead of Wednesday on account of PK's burn arm - being able to start on the venue bright and early on Wednesday morning instead of almost noon meant we got it done in a more relaxed manner, and more accurately than in years past. I already have my reservation at the Wildflower for Tues-Mon next year. For kicks, I brought up my game camera and stuck in on the Nanyee's Wellness pole, in time-lapse mode, pointed at the venue from Wednesday AM thru (past) closing. (Poor Jim got the job of "clearing" the tent - fortunately no skunk.)

Anne sent all chapter treasurers the form for the auditor to request bank balance information, as part of the audit process. I completed ours, and also gave Harry (the auditor) read access to our financials Dropbox folder.

Anyway, I'm hoping this will be my next-to-last report. New treasurer will need to work with me on the next one, for the September meeting.
